Webinar on Strengthening the Role of Public Institutions in Achieving Poverty Eradication and Sustainable Development



This Capacity Development Webinar, held on 16 October 2020, aimed to explore country experiences in achieving poverty reduction and eradication through strengthened public institutions, identify lessons learned and successful outcomes, and share recommendations on the way forward. The participants discussed challenges and shared lessons learned at the country level on how to revisit the role of public institutions in poverty eradication and sustainable development in the context of COVID-19 and what steps should be taken to strengthen and reinvigorate public

institutions to confront the crisis and to reduce and eradicate poverty. The webinar built upon the [11 Principles of Effective Governance for Sustainable Development](#) endorsed by ECOSOC, that seek to help build effective, accountable and inclusive institutions at all levels, with a view to achieving the shared vision for the people and the planet embodied in the 2030 Agenda for Sustainable Development. The Fifteenth Annual Meeting of the Internet Governance Forum (IGF) was hosted online by the United Nations under the overarching theme Internet for human resilience and solidarity.

The programme was developed around the four main thematic tracks: [\(1\) Data](#); [\(2\) Environment](#); [\(3\) Inclusion](#); [\(4\) Trust](#). The theme of "digital cooperation" and the UN Secretary-General's Roadmap for digital cooperation featured prominently.

The meeting was held from 9 to 17 November 2020. During this 7-day phase, workshops, main sessions, [the high-level leader's track](#), parliamentary roundtable and thematic concluding sessions were hosted.

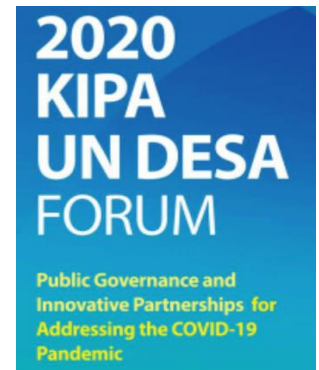

[Capacity Development Webinar on "Developing Institutional Capacities in Digital Transformation for a More Inclusive and Equitable Recover"](#)



This virtual capacity development webinar, held on 14-15 December 2020, aimed to strengthen public institutional capacities in public policymaking for digital transformation in support of 2030 Agenda for sustainable development. It aimed to strengthen the digital capacity of countries, especially the developing countries, and in particular the capacity of the LDCs, SIDS, LLDCs, and countries with transition economics, to participate in, and benefit from, the growing opportunities of digitalization while mitigating the risks.

The webinar brought together a network of relevant government officials (CIOs or equivalents), and experts and decision-makers from private sector, civil society, academia in relevant digital fields, including digital government, digital economy, cybersecurity, science, and technology, and innovation (STI).

Participants were invited to share lessons learned, including both success and failure, in address emerging requirements and challenges for policy and decision-making in regard to digital transformation and to reflect on partnerships and digital governance capacity to accelerate recovery and build a



more resilient infrastructure and inclusive service delivery. How to improve and strengthen the 2022 United Nations E-Government Survey was also discussed during the webinar. For more information, click [here](#).

[Under-Secretary-General for Economic and Social Affairs Mr. Liu Zhenmin launches 2021 United Nations Public Service Awards](#)



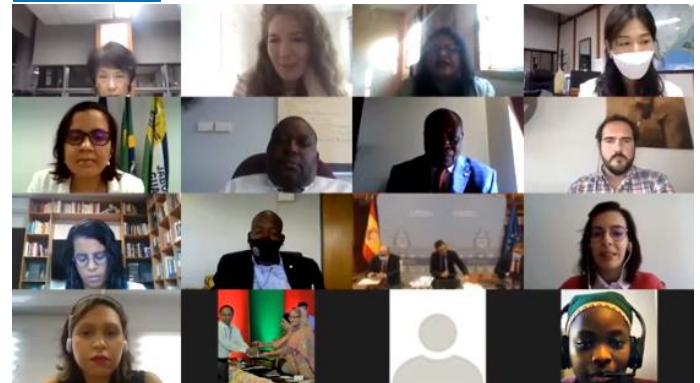
Mr. Liu Zhenmin, Under-Secretary-General for Economic and Social Affairs launched the 2021 United Nations Public Service Awards. The Awards, supported by UN DESA in collaboration with the United Nations Entity for Gender Equality and the

Empowerment of Women (UN Women), are an international recognition of excellence in public service.

The Awards recognize the innovation, creative achievements and contributions of public sector institutions leading to more effective and responsive public administration worldwide. In launching the Awards, Mr. Liu stressed the importance of effective public service delivery, and transparent, accountable and inclusive institutions in the Implementation of the 2030 Agenda for Sustainable Development. He noted in particular the need for enhancing efforts over the coming 'Decade of Action' leading up to 2030.

For the 2021 Awards nominations, public sector institutions were be considered under four categories: 1: Fostering innovation to deliver inclusive and equitable services for all, including through digital transformation; 2: Enhancing the effectiveness of public institutions to reach the SDGs; 3: Promoting gender-responsive public services to achieve the crisis. The event featured a broad panel discussion with experts, followed by regional breakout sessions led by UN DESA (English) and the UN Economic and Social Commission for Western Asia (Arabic). The event discussed these questions, among others:

- What are concrete examples of innovations that have helped people or institutions deal with the effects of COVID-19?
- How can the international community help to ensure that research and innovations related to COVID-19 are accessible to all?
- What needs to be done to better engage society, counter misinformation and overcome apathy towards science in policy-making?

The Annual Conference 2021 attracted papers that will invigorate discussion on the possible methods of citizens’ empowerment in the Central and Eastern European (CEE) region, in connection to its developments/traditions, governance practices, regulatory framework, financial capacity, public policy, digitalisation processes, human resource management and public administration itself. This topic was elaborated upon by experts, researchers and scholars from different disciplines, not only during the main session, but also in working groups and panel sessions. Civic participation and empowerment refer to a condition in which every citizen has the means to actively engage. This set also includes political processes, but the theme of the conference is designed much more broadly, so that civic participation and empowerment can be viewed in terms of all aspects, which consequently affect their everyday quality of life.
