Fifth Interregional Consultative Meeting of UNPAN Will Take Place on 7 November The Fifth Interregional Consultative Meeting of UNPAN will be held on 7 November 2003 in Mexico City, Mexico. The heads of <u>UNPAN members</u> will meet to focus on two major components. The first is to review the progress made in UNPAN since April 2002 at both the international and regional levels. The second is to discuss and reach a consensus on several major activities to be carried out in the near future, which include the expansion of UNPAN to the subregional level, enhancing the coordination of the activities of the UNPAN members for 2004-2005, UNPAN's participation in the United Nations Public Service Day/Awards 2004, and the report on the implementation of the UNPAN programme at the ORC/OIC level to the United Nations General Assembly. # **UNPAN Conducts Training Workshop on E-information Management**

The Fourth UNPAN Training Workshop on E-information Management was conducted by UNPAN-NY and held from 22-25 September 2003 in Thessaloniki, Greece. It was attended by 27 UNPAN network members from 17 regional and international institutions throughout the world.

The Workshop consisted of six parts: a) the introduction of new members, b) a report on the progress made since June 2002, c) an experience-sharing among all UNPAN members, d) technical training on the newly upgraded UNPAN system, e) a discussion on future actions, and f) a quiz, evaluation and conclusion.

In the course of the 3 ½ days of extensive work, and based on the results of the quiz and evaluation undertaken by all participants, six main objectives were achieved. The participants gained a better understanding of the general status of UNPAN's development, learned valuable experiences from each other on information management, and obtained better skills for the using the UNPAN technical system. In addition, two long-term working groups were established: one for content and one for ICT development. Finally, the cooperation among the members was strengthened both

bilaterally and multilaterally, and a consensus was reached on the actions to be undertaken in the near future.

Administration (OMAP), organised a "National Forum on Governance", at the National School of Administration of Rabat, Morocco, to present the results of the study on the "Evaluation of the governance system in the Kingdom of Morocco", that CAFRAD and OMAP accomplished for the United Nations Economic Commission for Africa (UNECA). The Final Report will be then presented in a Sub-regional Forum that will be organised by the North African Centre of UNECA in Cairo, 8-9 December 2003. The findings of the study will also serve for the preparation of the Fourth African Development Forum that will take place in Addis Ababa, 7-11 March 2004, and will focus on the theme "Governance for Progressing Africa".

# The Pan African Programme on Governance and Public Administration

Further to the 4th Pan African Conference of Ministers of Public Service (4-7 May, Stellenbosch, Cape Town, South Africa), organised by CAFRAD and the South African Ministry and Department of Public Service and Administration (DPSA) under the auspices of NEPAD, and with the support of UNDESA and specific donors, the African partner institution convened at the conference are implementing the decisions taken by Ministers in the "Stellenbosch Declaration", which, among other things, accepted the Governance and Public Administration Programme in Africa to be located within NEPAD and approved the "Pan-African Programme on Governance and Public Administration" (G&PA). # Machinea is Named ECLAC Executive Secretary

A former Argentinean economic minister has been appointed Executive Secretary of the United Nations Economic Commission for Latin America and the Caribbean (ECLAC). **José Luis Machinea** was the Economy Minister from December 1999 to February 2001, and he has also worked extensively in the private sector. He replaces **José Antonio Ocampo**, who is now the UN Under-Secretary-General for Economic and Social Affairs. He has worked as a consultant to the World Bank and the Inter-American Development Bank, as president of an Argentinean economic and social think-tank, and president of a private consulting firm. Mr. Machinea has also served as president of Argentina's central bank, as under-secretary of political economy, and under-secretary of planning. He holds a Ph.D. in economics and has taught graduate courses in macroeconomics, banking and monetary policy in Argentina. Most recently he has been a special expert in integration and trade at the Inter-American Development Bank.

# Regional Conference Promotes Renewable Energy Use in Latin America and the Caribbean

The United Nations estimates that almost 2.5 billion people - one-third of the world's population - lack access to modern energy services. At the Millennium Summit (2000), UN countries agreed that urgent measures should be adopted before 2015 to cut this figure in half and, along the way, reduce both the poverty in which many of the world's inhabitants live today and growing environmental pollution caused by the indiscriminate use of fossil fuels. On 29 and 30 October 2003, the Regional Conference for Latin America and the Caribbean on Renewable Energy took place in the Brazilian capital, Brasilia. The Conference, called by the government of that country and organized by ECLAC, sought to approve a regional platform on renewable energies for presentation to the International Conference for Renewable Energies to be held in Bonn, Germany, in 2004.

# **Expert Consultative Meeting on Public Administration and Public Accounting Development, with Stress on Electronic Tools**

[Jointly with Meeting on the Innovation of Public Administration in the Euro-Mediterranean Region (UNDESA)]

Dates: 1 - 3 July 2003

Location: UN-House, Beirut, Lebanon

The 'Expert Consultative Meeting on Public Administration and Public Accounting Development, with Stress on Electronic Tools' was held under the auspices of **H.E. Mr. Karim Pakradouni**, the Lebanese Minister of State for Administrative Reform. The meeting was organized by the Economic and Social Commission for Western Asia (ESCWA), the Office of State for Administrative Development (OMSAR), the United Nations Department of Economic and Social Affairs (UNDESA, New York), and Friedrich Ebert Foundation, in collaboration with the United Nations Development Programme (UNDP), the Lebanese Professional Computer Association (PCA), and the Association for the Development of Informatics and Law in Lebanon (ADIL). Four Arab Ministers participated in the meeting and contributed to the sessions as Chairpersons and through recommendations and discussion.

H.E. Mr. Said Khalfan Al-Ghaith (Minister of State) represented the United Arab Emirates, H.E. Mr. Najib Zerouali (Minister in Charge of Modernizing the Public Sector) represented Morocco, H.E. Mr. Abdelhakim Bourawy (Minister in Charge of Administrative Reform) represented Tunisia, as well as Mr. Karim Pakradouni; H.E. Mr. Abdelaziz Hegazi (ex-Prime Minister of Egypt) participated with an input paper on reform of budgeting systems. A Ministerial panel session was held and discussions between Ministers and experts took place to reach the best methods for administrative development. There were more than 100 participants from 19 countries; participants were experts from the ESCWA region and other regions as well as national representatives from ministries involved in public sector development in ESCWA

member countries and other Arab countries who shared the experience in this field. The meeting addressed the major issues facing public administration and public finance development in the region and in other regions with a focus on supporting electronic tools.

The Meeting on the Innovation of Public Administration in the Euro-Mediterranean Region discussed the challenges countries of the Mediterranean region are facing in the process of administrative development and the most relevant national challenges countries of the Arab region are facing in promoting economic and social development, and in fostering more participatory governance systems.

The important recommendations of the meeting requested ESCWA and the Division for Public Administration and Development Management (DPADM/DESA) to continue their effort and to run diagnostic surveys assessing the innovations in public administration and institutional development; to provide support for existing or new networks of innovators through UNPAN; to facilitate the sharing of e-services through UNPAN; to support the development of e-government in the Arab region, to hold regional fora and workshops on innovations and good practices in public administration and governance, and finally to run pilot programmes of innovations in public administration and governance at the national level.

The final report and all the recommendations of this meeting will soon be published on the meeting's Web page, which can also be checked for the proceedings of the meeting.
