

# XXVII International Congress of CLAD on State and Public Administration Reform

The Latin American Center for Development Administration (CLAD) and the Government of Bolivia, through the Ministry of Economy and Public Finance organized the XXVII International Congress of CLAD on State and Public Administration Reform that was held in Sucre, Bolivia, from 22 to 25 November 2022. It was attended by 2,200 people, in-person and online, from CLAD member countries and rest of the world. It included 92 panels, 29 special presentations, more than 480 speakers, the exhibition of 9 books published during the year 2022, the LII Meeting of CLAD's Board of Directors, the Meeting of Academic Advisory Council of the Ibero-American School of Administration and Public Policies of CLAD, the presentation and award of the winners of the XXXV CLAD Contest on the Sustainable Development Goals as a mechanism for institutional development, as well as meetings with different institutions, among other activities.

**Mr. Marcelo Montenegro Gómez García**, Minister of Economy and Public Finance, Bolivia, made an approach about the Productive Community Social Economic Model and its results.



United Nations Economic and Social Commission for Western Asia publication on World Development Challenges Report: Development from a Broader Lens



The current development scene has changed significantly in the past three decades. While some challenges, such as inequality and governance, have lingered or deepened. others such as sustainability and

global pandemics, have appeared or resurfaced. Also, even though many developing countries have made quantitative achievements on several basic development goals over the past few decades, persistent deficits remain in the quality of those achievements.

The United Nations Economic and Social Commission for Western Asia (ESCWA) produced a flagship publication on World Development Challenges Report: Development from a Broader Lens which proposes a new global Development Challenges Index (DCI) that measures shortfalls in achievements in three key and interdependent areas: quality-adjusted human development, environmental sustainability and good governance.

The report has four main findings:

- 1. A significant share of the world population still lives in difficult and in some cases deteriorating development conditions.
- 2. There is still much to be achieved, especially in terms of the quality of human development, even in the richest regions.
- 3. Environmental sustainability is a major concern for both developed and develop-ing countries.
- 4. Governance is the world's most pressing development challenge.

To address these deficits, the report suggests a four-pronged action plan that cuts across the three components of the DCI. This plan includes strengthening environmental and health systems to improve healthy life outcomes, building knowledge-based economies with integrated education and labour market systems, establishing strong links between government

#### CAF 2020 Total Quality Management framework – A Tool for Revamping Public Administrations in the Post-COVID Era

The Common Assessment Framework (CAF) is a total quality management tool (TQM) based on the European Foundation for Quality Management (EFQM) Excellence Model and the quality management model of the German University of Administrative Sciences in Speyer. CAF has been specifically designed for the development of TQM in public-sector organisations, starting with a self-assessment of their performance.

Since the launch of the first version of the CAF in 2000 until the most current version in 2020, over 4,000 organisations in European countries, EU institutions and non-EU countries have implemented this quality framework. The CAF is a free quality management model that enables public institutions across the globe to boost, efficiently transform and manage their performance. The CAF is also evidence-based and, as a living quality management tool, can partner with other tools and methodologies (such as human-centred design and agile management) during the optimisation of processes and services in any single public institution.

Motivation, trust, and enthusiasm – the capacity to innovate, learn, and benchmark organisations all over Europe is what brought participants together at the CAF 2020 Total Quality Management framework course, held at Maastricht, the Netherlands, from 23 to 25 November 2022. The

### EIPA Catalogue of Trainings 2023

Training has been one of the main pillars in EIPA's work over the decades. The institute has specialised in short courses that offer professionals a concise and practice-oriented understanding of issues, insight into the broader context and other actors' perspectives, and tools they can use in their jobs.

These are conceived as complementary to the services offered by national and private bodies, since they usually involve multinational perspectives and build on European networks and comparative research.

The courses address a range of learning needs. Some are designed primarily to explain how things work and to help people keep up to date with developments and perspectives. Many of these courses also aim to explain to national actors what they need to do to comply with EU rules or take advantage of EU funding. Others focus on skills, such as negotiating techniques.

In all cases, EIPA adopts a problem-solving approach and uses a variety of interactive methods to engage participants in thinking through and applying the information and insights acquired.

This document offers a non-exhaustive list of EIPA's training offer for 2023. The entries summarise the topics on which EIPA can offer expertise, and the main learning benefits of courses in these areas.
